FREE WEB-STORE TERMS AND AGREEMENT FORM

1. A free web-store will be created and one PDF flier can be created to make sales. For all other sale of all goods and products made form your web-store using your logo and organization name you agree they will be captured and collected by KD Shirt Shop & Sporting Goods. KD Shirt Shop & Sporting Goods will provide up to five design concept. KD Shirt Shop & Sporting Goods will charge \$10.00 for basic PDF flier design.
2. KD Shirt Shop & Sporting Goods will help create design concepts in 10 -14 business days of receiving your company information. KD Shirt Shop & Sporting Goods, will spend 5 hours creating a design concept for your web-store. Designs will be submitted for your review via E-mail unless otherwise negotiated. You will receive one free revision of each design. Further revisions will incur additional costs at KD Shirt Shop Sporting Goods current hourly rate of \$15.00 per hour two Hour Minimum .
3. All monies made before tax on basic garments sales via web-store or flier will be calculated and a percentage will be donated to you the user _____. Donation percentages are calculated by web-store net sales **\$250 in net sales = 10% - \$750 in net sales = 15% \$1,500 or more in net sales = 20%**. Names and numbers custom options on back of all garments will not be calculated into your web-store sales.
4. All donations will be submitted in the form of a check made payable to you or your organizations name _____. In addition, it is your responsibility to ensure that your customers know to submit payment with all flyer's to credit you or your organization with the funds received.
5. Either party may terminate this agreement at its convenience. In the event of termination, the donation percentage monies will be remitted to you or your organization in 30 days.
6. All web-store pricing will set by KD Shirt Shop & Sporting Goods. Unless other agreements have been made in writing only and singed by both parties.
